

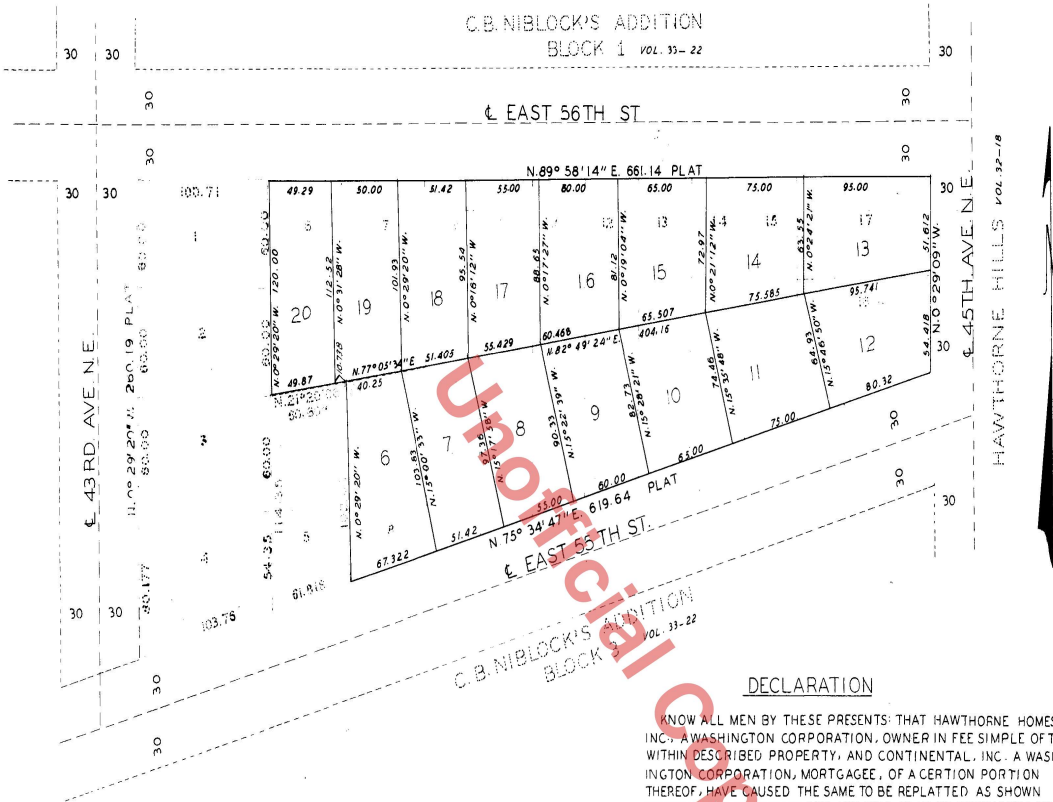
HAWTHORNE HOMES ADDITION
