DECLARATION OF RESTRICTIONS

The undersigned, Stanley F. Barker and Helen F. Barker, his wife, and The Homebuilding Company a corporation, owners, and H. T. Davis, Jr., mortgagee of the Plat known as Viewhome Addition to the City of Seattle, ashington, by the execution and recording of this instrument, do hereby establish the protective restrictions, conditions and covenants hereinafter set forth upon and subject to which all Lots, Tracts and Parcols of Land in said Plat shall hereafter be held or sold or conveyed by the as such owners and each and all of the present or future owners of land therein, as follows:

- 1. No building shall be erected on any building lot except one detached single-family dwelling and one or two car garage.


